Association Updates

Bylaws

The NAA's Association Bylaws have recently undergone a revision! Primarily, the Board intended these updates to provide clarity for the NAA's antiharassment policy; and secondarily, we hope these changes modernize the way the Board and membership can meet, e.g. online or via conference calls.

Questions, additional update suggestions, and concerns were discussed during the Annual General Membership Meeting on March 27, 2021.

The Bylaw updates were accepted by the Board, and will now undergo a third party outside legal review.

NAA Board Handbook

The NAA has drafted a Handbook for its Board Members. This document outlines the membership and Board Member roles, more formerly defines the Association's Activities, presents and defines awards and scholarships, structures the NAA's anti-harassment policy and code of ethics, and defines our conduct with membership data.


Silver Trowel 2022

INFORMATION ON MEMBERSHIP CATEGORIES

Membership categories are Regular, Family, Student, Corporate, Supporter, and Patron. Each member shall receive all of the NAA regular publications for the dues year and shall have one vote in the proceedings of the association. Publications include the *In Situ* newsletter and the annual *Nevada Archaeologist* journal.

Starting in 2020, Student members will have the option to pay a standard membership fee of \$25 or to pay a \$45 fee that will include registration for the Annual Meeting on March 6-8, 2020 in Pahrump! Student members paying the \$45 fee should submit a registration form at the meeting but will not be charged the registration fee.

Supporter and Patron members will receive one complimentary registration to the annual conference for the dues year and will be recognized in the conference program. Additionally, Patron members will receive one *gratis* banquet ticket for the conference.

Honorary members may be elected by a majority vote of the Board on recommendation of any member (in good standing) of the NAA. Each honorary member shall have full privileges in the association, which shall last their lifetime. Each corporate member shall assign one individual to cast its vote at the proceedings of the association.

Organizations wishing to be affiliated with the NAA must first apply in writing to the NAA Board. The applicant must include a current copy of the organization's bylaws and Code of Ethics. The NAA Board shall review applications at the next scheduled Board meeting following receipt of the application. Affiliated organizations pay dues at the Supporting level.

INFORMATION ON CHAPTERS

Members of the NAA may form local or topical chapters of the Association. Requests for new chapters must be made in writing to the NAA Board, and will be reviewed at the next scheduled NAA Board meeting.
